## 16. NEW BUSINESS

#### Motion 2024-04-14 - 01

PR moves that the Area Service Committee (ASC) allocate funds to purchase an Epson Ecotank 2800 wireless all-in-one printer as well as a 4 year warranty.

**Intent**: To address the issue of the discount card no longer being accepted, enable the area to become self-sufficient, and save significantly on printing costs.

## Financial Impact:

Printer: \$199.99 Warranty: \$34.99 Total w/ tax: \$249.08

#### Pros:

- One Time Purchase: The routine purchase of paper and ink required for the printer will be purchased by the Public Relations Subcommittee using funds from the meeting list budget line item.
- Increased self-sufficiency & autonomy: Having a printer available allows the ASC to operate independently, reducing reliance on external services and ensuring timely access to printed materials as needed despite any future variables.
- Cost-saving: By investing in a printer, the area can save significantly on printing costs over time, especially with the efficient ink system avoiding the need to purchase costly cartridges.
- Enhanced versatility: The printer will be available for the areas trusted servants, including but not limited to PR meeting lists, the Policy Subcommittee for policy printing, Hospitals & Institutions Subcommittee for meeting lists, activities or homegroups for printing flyers, and the Treasurer for scanning receipts and relevant documents. **Cons:**
- Maintenance requirements: The printer will require ongoing maintenance. Upfront cost: While the long-term savings are substantial, the initial investment of \$199.99 plus tax may strain the ASC budget.

## Motion 2024-04-14 - 02

PR moves that the Area Service Committee (ASC) allocate funds from the miscellaneous line item in the admin budget to rent an available locker, as well as purchase a combination lock to secure the locker.

**Intent**: To provide storage for the printer and its associated supplies.

## Financial Impact:

Locker Monthly Rent: \$10

Combination Lock One Time Cost: \$10

#### Pros:

- Secure storage: Renting a locker at provides a secure and centralized location for storing the printer and its supplies, protecting the equipment from theft, damage, or unauthorized access.
- Organization: Having a designated storage space helps maintain the printer and supplies in an orderly manner, facilitating easy access and inventory management.
- No reliance on individual members: By storing the printer and supplies in a rented locker, ASC ensures that the equipment is not housed at any one member's residence, mitigating the risk of misuse.

#### Cons:

- Additional expense: Renting a locker and purchasing a combination lock entail additional costs that may impact the budget.
- Maintenance responsibilities: ASC members are responsible for maintaining the rented locker.

#### 17. OPEN FORUM

- Question: Do we need another group inventory to discuss issues raised previously about how our group is reaching the newcomer?
  - Inventory came down from Region for homegroups to discuss. Group conscience is that questions were not highly relevant to our area. We should maybe consider doing an annual inventory
  - Support of the newcomer comes from the bottom up at the individual level, not from the top down at the area level
- Question: Has Admin discussed an annual learning day?
  - The spirit of rotation is suffering due to a lack of willingness in the fellowship
- **Question:** Do we have admin meetings?
  - Yes
  - Admin meetings and possible learning days are a good way to encourage the Area to serve its purpose as discussed earlier
  - Setting an individual, attracting rather than promoting. Also, fulfilling commitments is important
  - **Question:** Does policy need to pay rent?
    - Policy needs to get with the landlord about that
  - Gabe to step down as Alt Secretary.

#### **18. LITERATURE REPORT**

All is well with the literature sub-committee. Sales for this month are \$47.72 cash and \$81.38 cash app for a total of \$129.10. I'll be putting in a H&I order this month.
