From: If a willing NA member chooses to submit their information for jail clearance and receives clearance from the jail, they must attend orientation at the jail. After having attended orientation, they must attend one jail commitment meeting every three months while they are listed on the Speaker List as having jail clearance. If three months goes by without entering the jail, the member will be called and reminded of their commitment to speak. If the member is unwilling or unable to fulfill this commitment within six months, they will be dropped from the clearance list for the jail (not the general Speaker List) to allow room for those willing and able to go in.

To: If a willing NA member chooses to submit their information for jail clearance and receives clearance from the jail, the member must attend orientation at the jail. After having attended initial orientation, there is an annual re-orientation required to remain "active". This is to be done within the time frame of the last orientation, so that clearance will not be "suspended". Jail contact will provide a list to the subcommittee chair as to who is required to attend and when.
